Cover 3 Feeding, C3's Kid's Meals and Snack Program provides nutritious snacks and meals to all children in afterschool and summer programs throughout Southampton County, Greensville County, Sussex County, Hampton Roads, Chesapeake, Norfolk, Suffolk, Emporia, and the City of Franklin in Virginia. 3,900 kids benefited from this program.

Cover 3 Football provides several opportunities for football players to learn and grow in their individual and team fundamentals. Founder and CEO, Greg Scott, grew up playing youth football in Southampton County and understands the need to mentor young people through the game of football. There are several different football programs that have been set up for the youth in this area. They include youth football camps, football camps for food, middle and high school position workout camps, 7 on 7 combines and tournaments, and competitive teams. 800 kids benefited from this program.

Cover 3 is involved with community service and mentoring projects. They donate to local agencies that help families and at-risk youth. They provide volunteers to different community projects. They also provide mentoring to youth in the community by focusing on work ethic, attitude, and commitment. 5,500 people benefited.
